1. Organizational membership of AHRMIO is exclusively open to not-for-profit International Organizations. Membership is subject to approval by the organs of AHRMIO in accordance with its statutes and bye-laws.
2. The signatory of this AHRMIO Membership application form certifies he/she is a representative who is authorized to commit his/her organization to join AHRMIO.
3. The AHRMIO membership year starts on 1 January and finishes on 31 December. For those joining AHRMIO during the year, invoices will be reduced on a pro rata basis for the remaining part of the year
4. Cancellation policy: Renewal of membership is automatic, by tacit agreement. 3 months notice is required to resign from membership. The resignation has to be notified in writing to AHRMIO and will be validated by an acknowledgment of receipt by AHRMIO.
5. Use of data: The signatory of the present document authorizes AHRMIO to use all information communicated within the legal framework of its activities. AHRMIO respects the law on the protection of privacy.
6. AHRMIO may vote changes proposed by the AHRMIO Board to the annual fee schedule
7. Depending on the country where the credit card is issued, exchange rate fluctuations may lead to slight variations in the amount charged to your account.
8. If the transfer is made from a bank outside of Switzerland, please ensure that your instructions to make the transfer accept all charges (for both the remitting bank and the receiving bank).
9. The Swiss law shall apply to any and all disputes arising out of membership. In case of dispute, only the courts of Geneva are deemed competent.
